Important Instructions:

1. Breed Critiques completed outside the Judging Ring must represent 75% of the breeds accepted for championship competition. Please list 50 critiques by date, location, and breed on the listing form.
2. Must have completed at least 15 Breed/Breed Group Comparison Reports. Please list at least 15 comparisons by date, show or cattery location, breed(s) and instructor or cattery owner on the listing form.
3. Must list any additional training that may have been required. Indicate the kind of training on the listing form and provide documentation verifying completion.
4. Must have completed 40 Ring Training Sessions and 4 Solo Training Sessions. At least 10 (ten) Ring Training sessions and three (3) Solo Training Sessions must be with Licensed Ring instructors, six (6) Ring Training sessions and two (2) Solo Training sessions must be out of region or 500 miles from residence, and the final five (5) Ring Training sessions require the trainee to spend the entire day in the ring with the training judge. *Unless otherwise stated, all requirements must be scheduled by May 15th and completed by June 15th for application at the Annual, scheduled by October 15th and completed by November 15th for application at the Winter Meeting, or scheduled by January 15th and completed by February 15th for application at the Spring Meeting.* Attach the Trainee Tracking Form to this Application to document the above.
