Registration Rule 36.3.1 A cat of a recognized breed for whom one or both parents either are unknown or are not registered with TICA or an association which has a reciprocal registration agreement with TICA may be registered in the ancestry record of the association if the application for registration is accompanied by a signed Certification Form (R-1020) from three TICA Allbreed judges stating that they have evaluated the cat in question and find that it sufficiently meets the standard for its breed to be used in a breeding program.
